General Provisions

This Tariff includes all interest, fees and commissions charged for the services provided by MYFIN EAD to registered clients through the online customer service system “MyFin” (MyFin).

- Fees and commissions are collected in the currency in which the account was opened, or their equivalent in another currency.
- The euro equivalent of fees and commissions for euro-denominated operations set in a foreign currency is calculated on the basis of the foreign-currency exchange rates against the euro announced by the Bulgarian National Bank (BNB) for the relevant day.

EXCEPTIONS

This Tariff sets out the standard fees and commissions applied by MYFIN EAD, insofar as no other fees have been expressly agreed between the Company and its clients or correspondents for specific transactions.

Notes:

- Instant SEPA transfers are executed where the recipient's payment service provider (PSP) is reachable. Reachability exists when the recipient's PSP is certified and participates in the SEPA Instant Payments scheme.
- Transfers under Art. 1, item 1 are made to recipients registered for the P2P service, subject to the following limits: a) maximum transaction limit – EUR 255.65; b) total 24-hour limit – EUR 1,022.58.
- Where a payment transaction is executed within the EEA, the fees paid by the payer and the payee are shared (SHA) – each party pays the fees due to its own payment service provider.
 - Where payments are made in a currency other than that of an EEA member state and the payment service user is not a natural person, the fees may be charged entirely to the payer (OUR) or entirely to the payee (BEN), following individual arrangement with the servicing banks and where an agreement exists between the banks.
 - Where a payment transaction is executed outside the EEA, the fees are charged (OUR/SHA/BEN) as instructed by the payer and in accordance with the conditions of the relevant payment system.
- If the recipient's payment service provider is not reachable through the European payment systems, the transfer under Art. 2, item 2 is executed under the conditions and fees applicable to transfers under Art. 2, item 3 of this Section.
- Transfer orders accepted through MyFin by 15:00 are executed on the same business day; orders accepted after that time are executed on the following business day.
- The fee under Art. 5, item 1 is calculated on the transfer amount.
- The fee under Art. 5, item 5 is charged in addition to the transfer fee.
- The fee under Art. 5, item 7 is charged where additional information about the transfer is requested and obtained from a correspondent bank or the recipient.
